

### I. BACKGROUND

1. On 12 July 2018, Trial Chamber VIII ("Trial Chamber") issued its decision on the Trust Fund for Victims' ("Trust Fund") draft implementation plan in the present case,<sup>1</sup> wherein it directed the Trust Fund to submit monthly update reports, starting on 15 August 2018, in relation to the Trust Fund's progress in preparing an updated draft implementation plan ("UIP"). The Trial Chamber specified that each monthly update report should contain "concrete information on the actions taken in respect of each of the reparations modalities with timelines, objectives and staffing."<sup>2</sup>

2. On 15 August 2018, 14 September 2018, 15 October 2018 and 14 November 2018, the Trust Fund filed, respectively, its first,<sup>3</sup> second,<sup>4</sup> third<sup>5</sup> and fourth<sup>6</sup> monthly update reports. The Defence submitted observations to the latter on 5 December 2018.<sup>7</sup>

3. On 2 November 2018, the Trust Fund filed the UIP.<sup>8</sup>

4. On 21 November 2018, the Trial Chamber adopted the new application form proposed by the Trust Fund, subject to one change.<sup>9</sup>

5. On 30 November 2018, following the government of Mali's request for an extension of time,<sup>10</sup> the Trial Chamber set 8 January 2019 for the Malian authorities' observations on the UIP and 15 January 2019 for the parties' observations thereon.<sup>11</sup>

6. The Trust Fund hereby submits its fifth monthly update report. During the reporting period, activities in The Hague have revolved around the drafting of the Expression of Interest, and exchanges with both the legal representative of the victims

("LRV") and the Victims Participation and Reparations Section ("VPRS") concerning upcoming steps. There have also been missions to Mali and Paris for purposes of, respectively, the training of intermediaries and furthering the engagement with UNESCO.

#### II. CLASSIFICATION OF THE PRESENT SUBMISSION

7. Pursuant to regulation 23 *bis* (1) of the Regulations of the Court, the Trust Fund has classified this report confidential in line with the reasoning for its previous update reports.<sup>12</sup> No information is deemed necessary to redact from the parties.<sup>13</sup> A public redacted version of the information concerning further details relevant to the Board of Director's Complement Decision will be made available as soon as feasible.

### III. UPDATE REPORT OF 14 DECEMBER 2018

8. Pending the eventual approval of the UIP by the Trial Chamber, the Trust Fund has been making progress on aspects for which advanced planning can occur prior to the issuance of the Trial Chamber's decision.

9. Specifically, the Trust Fund made progress on the organisation of the outreach campaign and on the identification of new applicants for individual reparations. From 12 to 14 November 2018, the Trust Fund's Associate Field Programme Officer *de facto* in Mali and one legal staff,



10. By way of follow up, on 22 November, the Trust Fund met with the LRV to start planning the future outreach campaign to identify new applicants. During this meeting, issues such as the potential date of a joint mission to Bamako, identification of intermediaries and content of their training were discussed. On 11 December 2018, the Trust Fund met with VPRS to address similar topics and discuss a future collaboration.

11. In respect of the improvement of the protection and maintenance of the Protected Buildings and specifically the rehabilitation of cemetery walls, the Executive

Director, Board member Mme Doumbia as well as staff from the Trust Fund travelled to UNESCO HQ in Paris on 20 November 2018. Further to a formal engagement with UNESCO , a working level meeting took place to address matters such as joint resource mobilisation efforts to ensure funds for administrative and accompanying costs related to the protection and maintenance part of the UIP. The Trust Fund and UNESCO HQ have further agreed to move forward in formalising the partnership between the two organisations

A detailed agreement concerning programmatic collaboration will be developed in 2019

12. With respect to the EUR 1 symbolic award to UNESCO, the working level meeting also addressed the preparation of the joint Malian-UNESCO ceremony for the symbolic award to take place in Bamako at a date to be determined, and the joint publicity related to such ceremony and resource mobilisation activities.

13. Furthermore, the Trust Fund has examined which of the awards should be implemented by a partner and has drafted an Expression of Interest to this end. This concerns specifically the planting of trees and living hedges as a dune fixation technique around the the Sidi Mahamoud Ben Omar Mohamed Aquit Mausoleum; the Sheikh Sidi El Mokhtar Ben Sidi Mouhammad Al Kabir Al Kounti Mausoleum, the Alpha Moya Mausoleum and the Three Saints Cemeteries and the installation of lighting around the cemeteries that house mausoleums, as well as around the Sidi Yahia Mosque, Sidi Mahamoud, El Mokhtar and the Ahmed Fulani and Bahaber Bababdié mausoleums. In respect of economic rehabilitation, the Expression of Interest targets implementing partners capable of setting up the Economic Resilience Facility as described in the UIP. Bidders will be likewise called for the moral rehabilitation programmes.

14. Lastly, upon approval of the application form by the Trial Chamber, the Trust Fund applied the modifications required and shared the new form with the parties and the VPRS.<sup>14</sup> The amended form is attached to the present submission for the Trial Chamber's information.

# IV. FURTHER DETAILS RELEVANT TO THE BOARD OF DIRECTOR'S COMPLEMENT DECISION

15. The Trust Fund recalls that Norway and the United Kingdom had indicated their intent to contribute to the reparation awards in *Al Mahdi* with NOK 5 million and GBP 25,000, respectively.<sup>15</sup> These pledges were already included in the Board of Directors' decision to allocate EUR 1.35 million towards the *Al Mahdi* complement request notified to the Trial Chamber on 15 August.<sup>16</sup> The Trust Fund wishes to inform the Trial Chamber that it has now effectively received these pledges from both Norway and the United Kingdom.

16. The Trust Fund would like to express its deep gratitude to Norway and the United Kingdom for these donations, and reiterates its commitment to continue working diligently to identify additional donors in order to provide a full complement for the benefit of the victims in *Al Mahdi*.

## V. CONCLUSION

17. The Trust Fund stands ready to further appraise the Trial Chamber in relation to the information provided in this monthly report, or any other issue affecting the implementation phase of the present case.
