I. BACKGROUND

- 1. On 12 July 2018, Trial Chamber VIII ("Trial Chamber") issued a decision on the draft implementation plan wherein it directed the Trust Fund for Victims ("Trust Fund") to submit monthly update reports in relation to the Trust Fund's progress during the reparations implementation stage of the present case.¹
- 2. On 4 March 2019, the Trial Chamber approved the Trust Fund updated implementation plan² and agreed to the submission of such reports at a bimonthly basis ("Decision on the UIP").³

II. SUBMISSION

- 3. The Trust Fund appreciates the opportunity to submit update reports to the Trial Chamber on the implementation of the reparations as provided for in regulation 58 of the Regulations of the Trust Fund. In addition to serving the purpose of informing the Trial Chamber, the other parties and participants and the public of the progress of reparations, update reports permit keeping official records and constitute precious material to conduct lessons-learned exercises.
- 4. For the reasons set out below, the Trust Fund believes that submitting update reports every three months would reach the appropriate balance between ensuring the efficient use of Trust Fund's resources while permitting the oversight of the Trial Chamber.
- 5. The Trust Fund now enters into the phase of monitoring the work of its implementing partners. While the Trust Fund monitors the work of the implementing partners and works together with them on a daily basis (to ensure that implementation is conducted properly, in accordance with the Reparations Order and with the Trust Fund's best practices), it requires from the implementing partners that they submit quarterly

reports based on the quarters of a calendar year. Accordingly, aligning the Trust Fund's reporting to the Trial Chamber with the calendar of the implementing partner's reporting to the Trust Fund would permit a more efficient, consolidated and comprehensive reporting. Specifically, reporting mid-May, mid-August, mid-November and mid-February would permit including in the update reports to the Trial Chamber the latest developments in relation to collective reparations.

- 6. Spacing the submission would not have any adverse impact on the screening process. The Trust Fund proposes that in relation to the notification of administrative decisions on individual reparations applications, the same procedure remains in place, that is that positive decisions be notified by way of annexed list to the update reports and that the deadline to contest negative administrative decisions, if any, remains 15-day from their notification to the Trial Chamber, by way of annex of the decisions to the update report.⁴
- 7. Such a reporting period would allow the Trust Fund to focus its scarce resources on the implementation of reparations and nevertheless allow it to continue providing dense and complete reports. Should extraordinary events require urgent reporting to the Trial Chamber, the Trust Fund would submit *ad hoc* reports. Similarly, it is understood that the Trial Chamber may request at any time additional information from the Trust Fund.
- 8. The Trust Fund requests that this quarterly reporting period starts first with the 20th Update Report, which would be due on 18 May 2021.
- 9. For reasons of administrative and judicial economies, the Trust Fund requests the Trial Chamber that the page limit for the quarterly update reports be set to 30 pages. Considering the lesser frequency of the reports, it is the view of the Trust Fund that such an extension of page limit is prudent to avoid that requests for extension be unnecessarily filed ahead of the filing of the reports.
- 10. The 19th Update Report will be filed within the currently applicable page and time limitations.
