I. Introduction

1. On 7 July 2021, Trial Chamber VIII (“Chamber”) issued its “Decision on the Reclassification of Filings and Order on the Publicity of the Case Record” (“Decision”),¹ in which it instructed the Registry to reclassify as “public” several submissions and to file all outstanding email decisions in the case record, with appropriate redactions as necessary.²
2. The outstanding email decisions were identified in the Annex to the Decision.³

- The names of Registry staff members and team members of the parties and participants, except for the Counsel, the Senior Trial Lawyer and the Chiefs of Section.


7.
