**Trial Chamber VIII** of the International Criminal Court, in the case of *The Prosecutor v*. Ahmad Al Faqi Al Mahdi (the 'Al Mahdi case'), having regard to article 75 of the Rome Statute, rule 96 of the Rules of Procedure and Evidence ('Rules'), and regulation 23bis of the Regulations of the Court ('Regulations') issues this Fifth Order for the Publicity of the Case Record ('Fifth Order').

- 1. On 7 July 2021, after having conducted an additional review of the publicity of its case record, the Chamber issued an Order, inter alia, i) asking the reclassification of certain documents as public; ii) ordering the Trust Fund for Victims ('TFV') to file public redacted versions of filings ICC-01/12-01/15-361-Conf, ICC-01/12-01/15-364-Conf, and ICC-01/12-01/15-368-Conf; and iii) ordering the legal representative of victims ('LRV'), Defence, TFV, and Registry to file public redacted, or lesser redacted, versions of their filings submitted in the context of the reparations proceedings, or indicate which can be reclassified as public.1
- 2. On 22 July 2021, the LRV filed its submissions requesting the reclassification as public of certain documents, and indicating documents for which he would submit public redacted versions as well as documents for which the current classification as confidential and confidential ex parte should be maintained.<sup>2</sup>
- 3. On 31 August 2021, the TFV requested<sup>3</sup> the Chamber to reclassify as public filings ICC-01/12-01/15-361-Conf-Red, ICC-01/12-01/15-364-Conf, and ICC-01/12-01/15-368-Conf.
- 4. The Defence and the Registry did not make submissions.
- 5. Noting the TFV's and the LRV's submissions made in compliance with the Chamber's Order referred above, and pursuant to regulation 23bis(3) of the Regulations, the Chamber hereby orders:

A. The reclassification as public, without redactions, of the following filings from the TFV and the LRV:

- i. ICC-01/12-01/15-368-Conf;
- ii. ICC-01/12-01/15-364-Conf; and

- iii. ICC-01/12-01/15-363-Conf.
- B. The reclassification as public, maintaining the redactions, of the following filings from the TFV and the LRV:
  - i. ICC-01/12-01/15-389-Conf-Red;
  - ii. ICC-01/12-01/15-361-Conf-Red; and
- iii. ICC-01/12-01/15-356-Conf-Red.
- 6. In light of the request for reclassification by the LRV, the Chamber considers it also appropriate to order the reclassification as public of decision ICC-01/12-01/15-359-Conf.
- 7. Having reviewed the factual and legal basis provided by the LRV justifying the need to maintain the confidentiality of a series of documents,<sup>4</sup> in light of the applicable legal framework, the Chamber is satisfied that the basis for the classification of the following documents as confidential and confidential *ex parte* continues to exist and should therefore be maintained:
  - i. ICC-01/12-01/15-382-Conf-Exp-AnxA and ICC-01/12-01/15-382-Conf-Exp-AnxB;
  - ii. ICC-01/12-01/15-378-Conf-AnxA, ICC-01/12-01/15-378-Conf-AnxB, and ICC-01/12-01/15-378-Conf-Exp-AnxC;
  - iii. ICC-01/12-01/15-367-Conf-AnxA;
  - iv. ICC-01/12-01/15-363-Conf-AnxA;
  - v. ICC-01/12-01/15-362-Conf-Exp-AnxA;
  - vi. ICC-01/12-01/15-360-Conf-AnxA, ICC-01/12-01/15-360-Conf-Exp-AnxB, and ICC-01/12-01/15-360-Conf-Exp-AnxC; and
  - vii. ICC-01/12-01/15-355-Conf-Exp-AnxA.
- 8. In order to give to give full effect to the principle of publicity of the reparations proceedings, the Chamber hereby directs the Registry, TFV, and LRV, to file public redacted versions, lesser redacted versions of the public redacted versions, request the reclassification as public, or justify the need to maintain the current classification of the following documents within one month from the notification of the present decision:

- 9. Finally, the Chamber reiterates its order for the LRV, Defence, TFV, and Registry to continue to review their record on reparations and to file public redacted or lesser redacted versions of their filings submitted in the context of the reparations proceedings, or to

indicate which can be reclassified as public within one month from the notification of the present decision.<sup>5</sup>

## FOR THE FOREGOING REASONS, THE CHAMBER HEREBY,

**ORDERS** the reclassification as public, without redactions, of the following filings from the TFV and the LRV: ICC-01/12-01/15-368-Conf; ICC-01/12-01/15-364-Conf; and ICC-01/12-01/15-363-Conf;

**ORDERS** the reclassification as public, with redactions, of the following filings from the TFV and the LRV: ICC-01/12-01/15-389-Conf-Red; ICC-01/12-01/15-361-Conf-Red; and ICC-01/12-01/15-356-Conf-Red;

**ORDERS** the classification as public of decision ICC-01/12-01/15-359-Conf;

**DIRECTS** the Registry, TFV, and LRV, to file public redacted versions, lesser redacted versions of the public redacted versions, request the reclassification as public, or justify the need to maintain the current classification of the following documents, within one month from the notification of the present decision: ICC-01/12-01/15-267-Conf; ICC-01/12-01/15-232-Conf-Exp; ICC-01/12-01/15-441-Conf; ICC-01/12-01/15-386-Conf; ICC-01/12-01/15-377-Conf; ICC-01/12-01/15-371-Conf; ICC-01/12-01/15-366-Conf; ICC-01/12-01/15-358-Conf-Exp; ICC-01/12-01/15-291-Conf-Red; ICC-01/12-01/15-265-Corr-Red; ICC-01/12-01/15-256-Conf-Exp; ICC-01/12-01/15-253-Conf-Red3; ICC-01/12-01/15-440-Conf-Corr; ICC-01/12-01/15-370-Conf; ICC-01/12-01/15-315-Red; ICC-01/12-01/15-271-Conf; and ICC-01/12-01/15-348-Conf-Exp-AnxA;

**DIRECTS** the relevant authorities of Mali to a file public redacted version, request the reclassification as public, or justify the need to maintain the current classification of ICC-01/12-01/15-312-Conf-Anx, within one month from the notification of the present decision;

**REITERATES** its order for the LRV, Defence, TFV, and Registry to continue to review their record on reparations and to file public redacted or lesser redacted versions of their filings submitted in the context of the reparations proceedings, or to indicate which can be reclassified as public, within one month from the notification of the present decision.
