I. NOTIFICATION

1. Pursuant to Pre-Trial Chamber II's ("Chamber") 16 March 2023 "Decision on issues arising from the submission of the Document Containing the Charges" ("the Decision"),¹ the Prosecution submits its revised List of Evidence (Annex A), two revised Witness Tables (Annexes B and C), and a list of the items for which amendments to the disclosure metadata or disclosure notes were sought (Annex D).

II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified as "Confidential", pursuant to regulation 23*bis*(2) of the Regulations since they refer to documents and evidence which are currently subject to the same classification.

III. SUBMISSIONS

- 3. As per the Decision, the Prosecution submits its revised List of Evidence, which now includes: (i) the original items contained in the List of Evidence;² (ii) nine Trial Transcripts and their translations;³ (iii) the Call Data Records, Call Sequence Tables, and items used solely to substantiate telephone attributions;⁴ and (iv) the items referenced in the (analytical) Witness Table,⁵ that were not originally included in Annex to the DCC,⁶ which, pursuant to the Chamber's directions, was to include only "the most probative supporting evidence".⁷
- 4. As per the Decision, the Prosecution also submits two Revised Witness Tables.⁸ The (analytical) Revised Witness Table⁹ now includes all the references pertaining to witnesses, which were cited in the Annex to the DCC,¹⁰ but not included in the Witness
