Pre-Trial Chamber I

THE PRESIDENCY of the International Criminal Court (the 'Court');

NOTING the memorandum of 5 June 2023 from the Prosecutor addressed to the Presidency, in accordance with regulation 45 of the Regulations of the Court (the 'Regulations'), notifying the Presidency that on 23 May 2023 he received a referral in accordance with article 14(1) of the Rome Statute from the Government of the Democratic Republic of the Congo ('Situation in the Democratic Republic of the Congo II');¹

NOTING regulation 46(2) of the Regulations, pursuant to which the Presidency shall assign a situation to a Pre-Trial Chamber as soon as the Prosecutor has informed the Presidency in accordance with regulation 45 of the Regulations;

NOTING the composition of the Pre-Trial Division and the composition of its chambers, in addition to the current overall workload of Chambers in the Pre-Trial and Trial Divisions, as well as the individual workload of the judges serving in both Divisions;²

HEREBY DECIDES to assign the Situation in the Democratic Republic of the Congo II to Pre-Trial Chamber I with immediate effect.
