I. INTRODUCTION

1. Pursuant to Pre-Trial Chamber II's order on 25 August 2023,¹ the Defence for Mr Mokom ("the Defence") submits its updated List of Evidence.

II. SUBMISSIONS

2. On 24 August 2023, the Defence sought leave under Regulation 35 of the Regulations of the Court to add CAR-OTP-2066-1422 to its list of evidence ("the Request").²

3. The Chamber instructed the Prosecution to respond to the Request by 25 August 2023.³ The Prosecution responded that it did not oppose the addition of the document to the Defence List of Evidence.⁴

4. On 25 August 2023, the Chamber granted the Request, and ordered the Defence to file a revised List of Evidence by 29 August 2023, to include the item in question.⁵
