I. Introduction

1. The Victims and Witnesses Unit ("VWU" or "Unit") submits the present observations on the "Prosecution's submission pursuant to regulation 35 to vary the time limit and request for in-court protective measures for Witness P-0974" ("Request") pursuant to Trial Chamber V's ("Chamber") Order communicated by way of email, dated 17 August 2023 ("Order").

II. Classification

2. In accordance with regulation 23bis (2) of the Regulations of the Court, the present Observations are classified confidential as they refer to the Request which has the same classification.

III. Observations

- 3. The witness is a Central African Republic ("CAR") national, [REDACTED]. His mother tongue is Sango and he also speaks French. The witness is married and has 5 children. The witness holds [REDACTED].
- 4. On 23 August 2023, the VWU interviewed the witness to assess the need for incourt protection measures. The process was explained, the witness declared to have understood it and said that he needs protective measures during his testimony.
- 5. The witness stated that he is willing and ready to testify publicly, he however informed the VWU that he would feel more comfortable if he was granted in-court protection measures seeing that [REDACTED].
- 6. The witness did identify as potential threat actors [REDACTED] who might target him following his testimony. However, the witness stated that he did not

experience any security threats or incidents in relation to his cooperation with the

Court.

7. The VWU fails to see how testifying will jeopardise the witness' [REDACTED].

However, the fact that the witness [REDACTED], makes him susceptible to being

identified as a Court witness and therefore places him in potentially dangerous

situations.

8. This compounded with the fact that [REDACTED].

9. In conclusion, the VWU recommends that the Chamber consider granting the

witness in-court protective measures in the form of face distortion, use of closed

and/or private session for identifying information, use of a pseudonym and

redaction of any identifying information from any records that may be

disseminated to the public.
