## I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

## II. CONFIDENTIALITY

2. The Annex, appended to this filing, is classified confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

## III. SUBMISSIONS

3. On 30 January 2024 the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Trial INCRIM package 125” containing two items and “Trial Rule 77 package 094” containing four items.

4. On 2 February 2024 and on 6 February 2024 the Prosecution subsequently disclosed “Trial Rule 77 package 095” containing eighteen items and “Trial INCRIM package 126” containing three items.

5. Trial INCRIM package 125 comprises the witness preparation log and annex A to the witness preparation log of P-2519.

6. Trial INCRIM package 126 consists of the translation in French of the annex to the witness preparation log relevant to Witness P-2519, as well as the witness preparation log and annex relevant to Witness P-0622.

7. Trial Rule 77 package 094 comprises an unredacted version of call data records relevant to Witness P-1289 and three investigation reports regarding the history of contact between the Prosecution and Witnesses P-0358, P-0622 and P-0662 respectively.

8. Trial Rule 77 package 095 consists of 18 media files related to the witness preparation session relevant to Witness P-1289.
