## I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

## II. CONFIDENTIALITY

2. The Annex, appended to this filing, is classified confidential as it relates to evidence disclosed *inter partes* that should not be released to the public.

## III. SUBMISSIONS

3. On 22 February 2024 the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Trial INCRIM package 128” containing seven items and “Trial Rule 77 package 097” containing one item.

4. On 23 February 2024 the Prosecution subsequently disclosed to the Defence “Trial INCRIM package 129” containing four items and “Trial Rule 77 package 098” containing two items.

5. Trial INCRIM package 128 comprises the lesser redacted versions of witness P-0291’s passport and CV, the lesser redacted statements of witness P-2179, the witness preparation log and annex A to the witness preparation log of P-2179 and a newly registered version of the SRI register.

6. Trial Rule 77 package 097 comprises an investigation report regarding the Prosecution’s contact with witness P-2179.

7. Trial INCRIM package 129 comprises the witness preparation logs and annex to the witness preparation log of witnesses P-1524 and P-0291.

8. Trial Rule 77 package 098 comprises an investigation report regarding the Prosecution's contact with witnesses P-0291 and an investigation report about an error in relation to the ERN of a photograph in the witness statement of P-2179.
