**NOTING** the assignments of judges to the Pre-Trial Division, the Trial Division and the Appeals Division as of 16 March 2021;<sup>1</sup>

**NOTING** the election of Judge Tomoko Akane as President of the Court, Judge Rosario Salvatore Aitala as First Vice-President of the Court and Judge Reine Alapini-Gansou as Second Vice-President of the Court on 11 March 2024;<sup>2</sup>

**NOTING** article 39(1) of the Rome Statute ("Statute") and rule 4 *bis* of the Rules of Procedure and Evidence ("Rules");

**NOTING** that the Presidency has consulted with the judges in assigning them to the various divisions of the Judiciary, in accordance with paragraph 2 of rule 4 *bis* of the Rules;

**NOTING** that the Appeals Division is composed of Judge Tomoko Akane, following her election as President of the Court, and four other judges, in accordance with article 39(1) of the Statute;

**NOTING** that when assigning judges to divisions, the Presidency must balance a number of factors to the extent necessary and possible, as set out below, and that the guiding principles informing these factors are the applicable statutory framework and the need to ensure the efficient management of the Court's workload, including in view of the Court's long-term needs;<sup>3</sup>

**SEEKING** to ensure, to the extent possible, gender and geographical balance and representation of the world's principal legal systems within each division;<sup>4</sup>

**NOTING** the experience and expertise of each judge,<sup>5</sup> the relative judicial workload of each judge<sup>6</sup> and whether a judge has had any prior involvement relevant to a case, either as a judge of the Court or prior to commencing her or his judicial mandate;<sup>7</sup>

**HEREBY DECIDES** that the judges shall be assigned to the various divisions as follows,<sup>8</sup> with immediate effect:

**NOTING** the need to recompose a number of Trial Chambers and Pre-Trial Chambers in view of the above assignments and the end of judicial mandates of one or more of the judges of the Court;<sup>12</sup>

**NOTING** that, pursuant to article 39(2)(b)(i) of the Statute, the Appeals Chamber shall be composed of all the judges of the Appeals Division;

**NOTING** that, in view of the current level of activity in the cases before Trial Chambers, it is in the interests of judicial economy to reassign certain cases currently before them to a single Trial Chamber;

**DECIDES** to refer the case of *The Prosecutor v. Ahmad Al Faqi Al Mahdi* and *The Prosecutor v. Dominic Ongwen* to Trial Chamber II and hereby transmits the full record of the proceedings in those cases to that Chamber;

**DECIDES**, pursuant to article 74(1) of the Statute and rule 39 of the Rules, to assign alternate judges to the following cases: *The Prosecutor v. Ali Muhammad Ali Abd-Al-Rahman, The Prosecutor v. Alfred Yekatom and Patrice-Edouard Ngaïssona* and *The Prosecutor v. Mahamat Said Abdel Kani*, considering that, following their calling to full-time service, the assigned alternate judges will ensure their presence at each stage of the trial by certifying that she or he has familiarised her or himself with the record of proceedings. The Presidency considers that the assignment of alternate judges is appropriate in view of the current availability of judges assigned to the Trial Division and in order to avoid the risk of any unanticipated unavailability of a judge in the future having an adverse impact on the expeditiousness of proceedings and related financial implications;

**DECIDES** that the case of *The Prosecutor v. Laurent Gbagbo and Charles Blé Goudé* does not currently require assignment to a trial chamber;

**DISSOLVES** Trial Chamber VII, Trial Chamber VIII and Trial Chamber IX;

**DECIDES** to temporarily attach Judge Althea Violet Alexis-Windsor to the Pre-Trial Division and decides that the current temporary attachments to the Trial Division shall remain in place;<sup>13</sup>

**HEREBY CONSTITUTES** Pre-Trial Chamber III, in light of the Presidency's responsibility to ensure the efficient management of the pre-trial workload in accordance with article 38(3)(a) of the Statute, noting in particular the significant extent of the current and prospective workload at the pre-trial level and the specific needs of the confirmation of charges hearing in the case of *The Prosecutor v. Joseph Kony*;<sup>14</sup>

**HEREBY FURTHER DECIDES** to reassign the situation in Uganda, from Pre-Trial Chamber II to Pre-Trial Chamber III;

**DECIDES** that the composition of Chambers within the Trial and Pre-Trial Divisions shall be as follows, effective immediately;

**DECIDES** to call judges to full-time service in accordance with article 35(3) of the Statute, on the basis of the workload of the Court, applying an objective criterion of prioritising the calling to full-time service of judges who are nationals of States Parties which have never previously had a judge serving at the Court. Accordingly, the Presidency hereby decides to call Judge Damdin and Judge Motoc to serve on a full-time basis from 13 May 2024; Judge Ben-Mahfoudh and Judge Hohler to serve on a full-time basis from 10 June 2024 and Judge Paek and Judge Guillou to serve on a full-time basis from 19 August 2024;

**ORDERS** the Registrar to file and notify the present decision to the relevant parties and participants in all relevant situations and cases.
