**PRE-TRIAL CHAMBER III** (the ‘Chamber’) of the International Criminal Court (the ‘Court’) issues this notification of the election of the Presiding Judge.

1. On 12 March 2024, the Presidency of the Court recomposed the Chambers and assigned the situation of the Republic of Uganda and cases therein to this Chamber.<sup>1</sup>
2. The Chamber notes regulation 13(2) of the Regulations of the Court, pursuant to which the Judges of each Pre-Trial Chamber ‘shall elect from amongst their members a Presiding Judge who shall carry out the functions conferred upon him or her by the Statute, Rules or otherwise’.
3. On 13 March 2024, the Judges of the Chamber elected Judge Althea Violet Alexis-Windsor to act as the Presiding Judge of the Chamber with immediate effect.
