**Trial Chamber II** of the International Criminal Court ('Court') issues the following 'Decision Notifying the Election of a Presiding Judge and Single Judge', in the case of *The Prosecutor v. Bosco Ntaganda*, pursuant to Regulation 13(2) of the Regulations of the Court.

- 1. On 12 March 2024, the Presidency of the Court decided on the composition of Trial Chamber II, naming Judges María del Socorro Flores Liera, Kimberly Prost and Nicolas Guillou, and referred the cases of *The Prosecutor v. Thomas Lubanga Dyilo*, *The Prosecutor v. Germain Katanga*, *The Prosecutor v. Bosco Ntaganda*, *The Prosecutor v. Ahmad Al Faqi Al Mahdi and The Prosecutor v. Dominic Ongwen* to Trial Chamber II.<sup>1</sup>
- 2. The judges of Trial Chamber II have elected Judge María del Socorro Flores Liera as Presiding Judge and as Single Judge.
