**PRE-TRIAL CHAMBER I** (the ‘Chamber’) of the International Criminal Court (the ‘Court’), following its recomposition, issues this decision on the election of the Presiding Judge.

1. On 12 March 2024, the Presidency of the Court recomposed the Chambers and assigned the following situations to the Chamber: Democratic Republic of the Congo I; Democratic Republic of the Congo II; Libya; Republic of Mali; Gabonese Republic; Registered Vessels of Comoros, Greece and Cambodia; Palestine; People’s Republic of Bangladesh and the Republic of the Union of Myanmar; Plurinational State of Bolivia; Georgia; Bolivarian Republic of Venezuela I; Bolivarian Republic of Venezuela II; and Republic of Philippines.<sup>1</sup>
2. The Chamber notes regulation 13(2) of the Regulations of the Court, pursuant to which the Judges of each Pre-Trial Chamber ‘shall elect from amongst their members a Presiding Judge who shall carry out the functions conferred upon him or her by the Statute, Rules or otherwise’.
3. On 18 March 2024, the Judges of the Chamber elected Judge Iulia Motoc to act as the Presiding Judge of the Chamber with immediate effect.

**FOR THESE REASONS, THE CHAMBER HEREBY**

- a) **ANNOUNCES** the election of Judge Iulia Motoc as the Presiding Judge of Pre-Trial Chamber I; and
- b) **ORDERS** the Registrar to file and notify the present decision to the relevant parties and participants in the following situations: Democratic Republic of the Congo I; Democratic Republic of the Congo II; Libya; Republic of Mali; Gabonese Republic; Registered Vessels of Comoros, Greece and Cambodia; Palestine; People's Republic of Bangladesh and the Republic of the Union of Myanmar; Plurinational State of Bolivia; Georgia; Bolivarian Republic of Venezuela I; Bolivarian Republic of Venezuela II; and Republic of Philippines.
