## I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

## III. SUBMISSIONS

3. The Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Trial INCRIM package 132” containing six items on 15 March 2024, “Trial Rule 77 package 101” containing three items on 19 March 2024, and “Trial INCRIM package 133” containing 16 items on 20 March 2024.
