#### I. Introduction

1. The Registry submits with the present report and its annexes 1 to 6, the public and confidential versions of email decisions pursuant to the "Directions on the conduct of proceedings" ("Directions"), issued on 9 March 2022 by Trial Chamber VI ("Chamber"). Its Annex 7 is submitted as Secret *EX PARTE* only available to the Registry Detention Section and ODJSS.

## II. Procedural History

- 2. On 9 March 2022, the Chamber issued the Directions instructing the Registry to file all email decisions on the case record in quarterly reports<sup>4</sup>, which also should comprise the decisions issued up to the publication date of the Directions.<sup>5</sup>
- 3. The Chamber further directed the parties and participants to: i) frame their requests made by email in a way that make their publicity possible; and ii) indicate in the email when emails cannot be made public at all.<sup>6</sup>

#### III. Classification

4. Pursuant to regulation 23*bis*(1) of the Regulations of the Court and Regulations 14(d) of the Regulations of the Registry, annexes 1 to 6 are classified as "confidential" and annex 7 is classified as "secret" because they refer to

sensitive information that should not be disclosed to the public or are known only to a very limited number of persons.

## IV. Applicable law

5. For the purpose of the present submission, the Registry considered articles 64(7), 64(10) and 67(1) of the Rome Statute and rule 137 of the Rules of Procedure and Evidence.

#### V. Submissions

- 6. In the Directions, the Chamber provided criteria for the application of the redactions to the email decisions. The Registry was instructed *inter alia* to apply redactions to i) names of Chambers staff members, where applicable; ii) names of Registry staff members, if deemed necessary by the Registry; and iii) any personal email address or other private or personal information. The Registry shall consult the parties and participants on the redactions applied.<sup>7</sup>
- 7. Accordingly, the Registry applied redactions to emails set forth in the following 6 public annexes with the exception of annex 7 only submitted as secret EX PARTE only available to the Registry Detention Section and ODJSS:
