I. INTRODUCTION

1. As instructed by the Chamber on 8 April 2024¹, the Registry hereby transmits to Pre-Trial Chamber III (“Chamber”), in accordance with Rule 13(1) of the Rule of Procedure and Evidence, a Request to submit as *Amicus Curiae* received from the ICCBA.

II. PROCEDURAL HISTORY

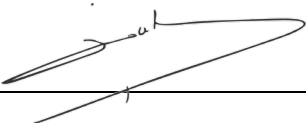
