## I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication filing regarding the disclosure of evidence.

## II. CONFIDENTIALITY

## III. SUBMISSIONS

3. The Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Trial INCRIM package 137” containing eleven items, and “Trial Rule 77 package 105” containing fifteen items on 25 April 2024.

4. Trial INCRIM package 137 comprises four translations, one investigation report related to Witness P-0358, two witnesses preparation logs and their annexes related to Witnesses P-1180 and P-0358, one handwritten document and one pay slip.
