I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annex, appended to this filing, is classified confidential as it relates to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. On 8 May 2024 the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Trial INCRIM package 138” containing 48 items, “Trial Rule 77 package 106” containing 13 items and “Trial Metadata Update Package 015” containing one item.

4. Trial INCRIM package 138 comprises the witness statements of Witnesses P-0954, P-1958, P-0884, P-2027; the transcripts of the testimony of Witnesses P-2232, P-2328 and P-1339; documents related to the anticipated testimony of Witness P-0481 and the original version of Annex A to the witness preparation log of Witness P-0358.
