I. Transmission

1. On 4 June 2024, Trial Chamber VI ("Chamber") ordered the Registry to file on the case record the Defence's proposed redacted version of the report of the appointed expert ("Expert's Report") and the Defence's justification for any redactions ("Defence's justifications").¹ The Registry therefore transmits in Annex I, the redacted version of the Expert's Report, and in Annex II, the Defence's justifications.

II. Classification

2. Considering regulation 24*bis* of the Regulations of the Court and regulation 14(d) of the Regulations of the Registry, the present submission is classified as Secret as it follows the level of classification ordered in the Chamber's Decision,² Annex I is classified as Secret since (1) it follows the level of classification ordered in the Chamber's Decision³ and (2) it contains sensitive information from the Expert labelled medical confidential and Annex II is classified Secret *ex parte* only available to the Defence for Mr Said and the Registry as it follows the level of classification ordered in the Chamber's Decision.⁴
