**The Article 85 Chamber** (the ‘Chamber’) of the International Criminal Court, having regard to regulation 23bis(3) of the Regulations of the Court (the ‘Regulations’), issues the following ‘Order for reclassification of ICC-01/14-01/22-335-Conf’ in the case of *The Prosecutor v. Maxime Jeoffroy Eli Mokom Gawaka*.

1. On 17 April 2024, a request for compensation pursuant to article 85 of the Rome Statute was filed by Mr Mokom.<sup>1</sup>
2. On 8 May 2024, the Prosecution filed the ‘Prosecution’s Response to Maxime Mokom’s Request for Leave to Reply to Prosecution’s Response to his Request for Compensation under article 85 of the Rome Statute’ (the ‘Prosecution Response’).<sup>2</sup>
3. On 28 June 2024, the Chamber filed its Order for submission of public redacted versions of filings, in which it, *inter alia*, instructed the Prosecution to file a public redacted version or request reclassification as public of the Prosecution Response by 5 July 2024.<sup>3</sup>
4. On 4 July 2024, the Prosecution requested that the Chamber reclassify the Prosecution Response as public.<sup>4</sup>
5. Having considered the Request, pursuant to regulation 23bis(3) of the Regulations, the Chamber hereby orders the reclassification of the Prosecution Response (ICC-01/14-01/22-335-Conf) to public.

**FOR THESE REASONS, THE CHAMBER HEREBY**

**ORDERS** the reclassification of the Prosecution Response (ICC-01/14-01/22-335-Conf) to public.
