The Single Judge of Trial Chamber II of the International Criminal Court, having regard to regulation 23bis(3) of the Regulations of the Court (the ‘Regulations’), issues the following ‘Order for reclassification of ICC-01/04-02/06-2884-Conf’ in the case of *The Prosecutor v. Bosco Ntaganda*.

1. On 1 December 2023, counsel for Mr Ntaganda filed a ‘Statement provided by Mr Bosco Ntaganda on 30 November 2023 regarding reparations proceedings’, which included a covering submission (ICC-01/04-02/06-2884-Conf) and annexed statement of Mr Ntaganda (ICC-01/04-02/06-2884-Conf-AnxA).¹
2. On 19 June 2024, the Single Judge instructed counsel for Mr Ntaganda to either file public redacted versions, request the reclassification as public, or justify the need to maintain the current classification as confidential, if applicable, of ICC-01/04-02/06-2884-Conf and ICC-01/04-02/06-2884-Conf-AnxA.²
3. On 3 July 2024, counsel for Mr Ntaganda filed a public redacted version ICC-01/04-02/06-2884-Conf-AnxA³ as well as a request for reclassification of filing ICC-01/04-02/06-2884-Conf to public.⁴
4. Having considered the Request, pursuant to regulation 23bis(3) of the Regulations, the Single Judge hereby orders the reclassification of ICC-01/04-02/06-2884-Conf as public.

FOR THESE REASONS, THE CHAMBER HEREBY

ORDERS the reclassification of ICC-01/04-02/06-2884-Conf as public.
