Pre-Trial Chamber I

THE PRESIDENCY of the International Criminal Court (the ‘Court’);

NOTING the memorandum of 30 September 2024 from the Prosecutor addressed to the Presidency, in accordance with regulation 45 of the Regulations of the Court (the ‘Regulations’), informing that on the same day, he had received from the Government of the Republic of Lithuania a referral under articles 13(a) and 14 of the Rome Statute regarding the situation in the Republic of Lithuania/Republic of Belarus;¹

NOTING regulation 46(2) of the Regulations, pursuant to which the Presidency shall assign a situation to a Pre-Trial Chamber as soon as the Prosecutor has informed the Presidency in accordance with regulation 45;

NOTING the ‘Decision assigning judges to divisions and recomposing Chambers’ issued on 12 March 2024;²

HEREBY DECIDES to assign the situation in the Republic of Lithuania/Republic of Belarus to Pre-Trial Chamber I with immediate effect.
