NOTING the "Prosecutor's Application for warrants of Arrest, Article 68" (the Application") filed by the prosecution in respect of Thomas Lubanga Dyilo and Bosco Ntaganda on 12 January 2006;

NOTING the "Decision on the Prosecutor's Application for Warrants of Arrest, Article 58"² ("the Decision") issued by the Chamber on 10 February 2006, in which the Chamber rejected the warrant of arrest for Bosco Ntaganda on the basis of the inadmissibility of the case against him;

NOTING the Prosecution's appeal against the Decision filed by the Prosecution on 14 February 2006;³

NOTING the Appeals Chamber "Judgment on the Prosecutor's appeal against the decision of Pre-Trial Chamber I entitled 'Decision on the Prosecutor's Application for Warrants of Arrest, Article 58'"⁴ ("the Appeals Chamber Judgement") issued on 13 July 2006;

NOTING the arrest warrant against Bosco Ntaganda⁵ issued by the Chamber on 22 August 2006;

NOTING the Memorandum submitted by Judge Akua Kuenyehia and Judge Sylvia Steiner requesting the Presidency to excuse them from the case of *The Prosecutor v. Bosco Ntaganda*¹⁰ ("the Memorandum") dated 10 March 2008;

CONSIDERING that the Prosecution's request for unsealing in the case of *The Prosecutor v. Bosco Ntaganda* is still pending before the Chamber, it is the view of the Chamber that the Prosecution must be made aware of the Memorandum;
