1. Pre-Trial Chamber III (the "Chamber") of the International Criminal Court (the "Court") is seized of a "Notification to Pre-Trial Chamber III and Request for Extension of Page Limit and Expedited Consideration" (the "Request") filed by the Prosecutor in the record of the situation on 2 May 2008¹.

2. In the Request, the Prosecutor primarily seeks an extension of the page limit regarding an upcoming application to 70 pages pursuant to regulation 37(2) of the Regulations of the Court (RoC)².

3. In the Request, the Prosecutor also informs the Chamber that he "will respectfully request that the application be considered on expedited basis"³.

4. The Chamber will first address the issue of expeditiousness and in this respect reiterates that expeditiousness is a major principle of the proceedings before the Court and that it is an inherent responsibility of all its organs⁴.

5. The Chamber notes that the Request for expedited consideration concerns in fact the upcoming application referred to in the Request.

6. With regard to the request for extension of page limit, the Prosecutor submits that the extension is necessary due to the importance of the issues to be dealt with and the necessity to present them clearly in the upcoming application, the need to set out in the application the relative merits of employing article 58 (1), the complex nature

of the facts with which the application is concerned, and the need for the Chamber to be provided with an adequate description of them, even though summarized, in order to enable the Chamber to make an informed decision⁵.

7. The Chamber notes that pursuant to regulations 37(2) and 38(2)(e) of the RoC "[t]he Chamber may, at the request of a participant, extend the page limit in exceptional circumstances", and that "[u]nless otherwise ordered by the Chamber, the page limit shall not exceed 50 pages for a request by any participant to the pre-Trial Chamber to (...) issue orders and warrants".

8. The Chamber finds that the reasons relied on by the Prosecutor in the Request, in their entirety, constitute exceptional circumstances within the meaning of the above-stated provisions.

FOR THESE REASONS, THE CHAMBER DECIDES

a) Not to deal with the request for expedited consideration of the upcoming application as being without merits at this stage of the proceedings;

b) To grant the Prosecutor an extension of page limit to seventy (70) pages.
