THE JUDGES OF PRE-TRIAL CHAMBER II (“the Chamber”) of the International Criminal Court are seized with the matter of the election of a Presiding Judge.

1. The Chamber notes the “Decision assigning the situation of Uganda to Pre-Trial Chamber II” issued by the Presidency on 5 July 2004.¹

2. The Chamber recalls that Pre-Trial Chamber II was composed of Judge Mauro Politi (Presiding Judge),² Judge Hans-Peter Kaul and Judge Ekaterina Trendafilova.³ The Chamber further recalls that the term of office of Judge Mauro Politi ended on 10 March 2009.

The Chamber notes the “Decision on the constitution of Pre-Trial Chambers and on the assignment of the Central African Republic situation” issued by the Presidency on 19 March 2009⁴ whereby Judge Mauro Politi was replaced with Judge Fumiko Saiga. The assignment of the situation of Uganda remained unchanged to Pre-Trial Chamber II.

The Chamber notes regulation 13(2) of the Regulations of the Court pursuant to which the judges of each Pre-Trial Chamber shall elect a Presiding Judge from amongst their members.

The Chamber also notes the meeting of the judges of Pre-Trial Chamber II on 23 March 2009 during which it was decided that Judge Ekaterina Trendafilova will act as the Presiding Judge of the Chamber in the situation of Uganda with immediate effect.




THE CHAMBER HEREBY

- a) **decides** that Judge Ekaterina Trendafilova is the Presiding Judge of Pre-Trial Chamber II in the situation of Uganda and any cases emanating therefrom;
- b) **orders** the Registrar to file this decision in the record of the situation of Uganda and any case emanating therefrom, including the case of the Prosecutor v. Joseph Kony, Vincent Otti, Okot Odhiambo and Dominic Ongwen.
