THE JUDGES OF PRE-TRIAL CHAMBER I of the International Criminal Court (the "Chamber" and the "Court", respectively);

NOTING the "Decision assigning the Situation in the Democratic Republic of Congo to Pre-Trial Chamber I" issued by the Presidency on 5 July 2004;¹

NOTING the "Decision on the Designation of a Single Judge" issued by the Chamber on 10 May 2007, appointing Judge Sylvia Steiner as the Single Judge of Pre-Trial Chamber I responsible for the situation in the Democratic Republic of the Congo (the "DRC") and any related case from 10 May 2007 until otherwise decided by the Chamber;²

NOTING the "Decision on the Designation of a Single Judge" issued by the Chamber on 11 March 2008, confirming that Judge Sylvia Steiner shall remain the Single Judge concerning the Situation in the DRC and any related case;³

NOTING the "Decision on the constitution of Pre-Trial Chambers and on the assignment of the Central African Republic situation"⁴ issued by the Presidency on 19 March 2009 whereby the situation in the DRC remains assigned to Pre-Trial Chamber I and Judges Akua Kuenyehia and Anita Ušacka were replaced with Judges Sanji Mmasenono Monageng and Cuno Tarfusser;

NOTING articles 39(2)(b)(iii) and 57(2)(b) of the *Rome Statute* ("the Statute"), rule 7(1) of the *Rules of Procedure and Evidence* ("the Rules") and regulations 47(1) of the *Regulations of the Court* ("the Regulations");

CONSIDERING that pursuant to article 39(2)(b)(iii) of the Statute, the functions of the Pre-Trial Chamber shall be carried out either by three judges of the Pre-Trial Division or by a single judge of that Division in accordance with the Statute and the Rules;

CONSIDERING that pursuant to article 57(2)(b) of the Statute, in all cases other than those listed in article 57(2)(a) of the Statute, a single judge of the Pre-Trial Chamber may exercise the functions provided for in the Statute, unless otherwise provided for in the Rules or by a majority of the Pre-Trial Chamber;

CONSIDERING further that rule 7(1) of the Rules and regulation 47(1) of the Regulations establish that the designation of a single judge shall be based on objective criteria agreed upon by the Pre-Trial Chamber, including consideration of the issues involved, the circumstances of the proceedings before the Chamber, the distribution of work within the Chamber and the proper management and efficiency in the handling of cases;

CONSIDERING that in light of the abovementioned criteria, in particular the new constitution of the Chamber, the need to ensure proper management and efficiency in the handling of the proceedings before the Chamber, as well as the fact that Judge Sylvia Steiner has been designated Single Judge in relation to the proceedings of the situation in the DRC and any case emanating therefrom including the case of *The Prosecutor v.
