Background

On 10 February 2009, Counsel for Germain KATANGA filed a motion challenging the admissibility of the case ("Motion"). The Defence annexed to its Motion a number of documents originating from the file of the *Auditeur Général Militaire* of the Congolese national army (the "FARDC").

On 24 February, the Motion was reclassified as Confidential, accessible to the Prosecution and both Defence teams.¹

On 6 March, the Legal Representatives of Victims and the Office of Public Counsel for Victims ("OPCV") were informed that the Defence had filed a motion challenging the admissibility of the case.²

On 11 March, a public redacted version of the Motion was made available³ and on 26 March, a summary of the Motion was disclosed to the Legal Representatives of Victims and the OPCV.⁴

On 16 April, the Legal Representatives of Victims requested the disclosure, without redactions, of the documents from the file of the *Auditeur Général Militaire*, as disclosed by the Prosecution to the Defence team of Mr Germain Katanga.⁵

On 22 April, the Office of the *Auditeur Général Militaire* confirmed that it does not object to the reclassification, by the Chamber, of the documents of the file of the *Auditeur Général Militaire* referred to by the Defence of Mr Katanga. The Office of the *Auditeur Général Militaire* requests that the documents be reclassified as Confidential, accessible to the Legal Representatives of Victims and the OPCV with the same redactions as applied by the Prosecution (if any) when the documents were initially disclosed to the Defence.
