CONSIDERING that the grounds according to which the First and Second Decisions were issued are still valid in so far as Mr. Mathieu Ngudjolo Chui is concerned and, that the post-factum listening of the non-privileged telephone communications of Mr Mathieu Ngudjolo from October 2008 provides information in respect to the activities listed under regulation 175 (1) of the Regulations of the Registry that need to be further analysed and, it is likely that the continuation of the post-factum listening of his telephone communications will allow the Registry to have a better understanding of previous communications;
