THE JUDGES OF PRE-TRIAL CHAMBER II (the "Chamber") of the International Criminal Court are seized of the matter of electing a Presiding Judge in the situation of the Republic of Kenya and any case emanating therefrom.

- 1. The Chamber notes the "Decision assigning the situation in the Republic of Kenya to Pre-Trial Chamber II" issued by the Presidency on 6 November 2009.
- 2. The Chamber recalls that Pre-Trial Chamber II, composed of Judge Ekaterina Trendafilova, Judge Hans-Peter Kaul and Judge Cuno Tarfusser, has been assigned with the situations in Uganda and the Central African Republic.
- 3. The Chamber also recalls its past decision electing Judge Ekaterina Trendafilova as Presiding Judge of Pre-Trial Chamber II in both situations².
- 4. The Chamber notes regulation 20(1) of the Regulations of the Registry according to which a new situation record is opened once the Presidency has assigned the situation to a Pre-Trial Chamber.
- 5. The Chamber further notes regulation 13(2) of the Regulations of the Court pursuant to which the judges of each Pre-Trial Chamber shall elect a Presiding Judge from amongst their members. The Chamber further notes that the election of a Presiding Judge is irrespective of any assignment of situation(s) or case(s) to that Chamber. Accordingly, it is the understanding of the judges that a previous decision regarding the election of a Presiding Judge applies to any newly assigned situation(s) and related case(s), unless decided otherwise by the members of the Chamber.

It is clarified that a decision electing a Presiding Judge had to be taken anew on 23 March 2009 as Pre-Trial Chamber III, presided by Judge Ekaterina Trendafilova, was dissolved and merged with Pre-Trial Chamber II, which had been presided by Judge Mauro Politi until his term of office ended.

FOR THESE REASONS, THE CHAMBER HEREBY

- **a) decides** that Judge Ekaterina Trendafilova continues to be Presiding Judge of Pre-Trial Chamber II in any situation or case before that Chamber;
 - **b) orders** the Registrar to file this decision in the record of the situation of the Republic of Kenya and, subsequently, any case emanating therefrom;
 - c) orders the Registrar to file this decision in the record of any situation newly assigned to Pre-Trial Chamber II and in the record of any related case emanating therefrom.
