NOTING Trial Chamber I's decision of 26 June 2009¹ in which the Chamber requested that the application forms of victims a/0225/06, a/0229/06 and a/0270/07 (in full or with necessary redactions) be filed confidentially;

NOTING Me Keta's request of 14 August 2009² in which Me Keta requested that certain redactions be maintained in the application forms;

NOTING Me Keta's filing of 7 January 2010³ by which Me Keta transmitted to the parties the application forms of victims a/0225/06, a/0229/06 and a/0270/07 with limited redactions;

CONSIDERING that the application forms transmitted by Me Keta⁴ on 7 January 2010 did not include the supplementary documents related to the applications of victims a/0225/06, a/0229/06 and a/0270/07;

CONSIDERING that the Defense requested to the Trial Chamber on 7 January 2010 to have access to the supplementary documents related to the applications of victims a/0225/06, a/0229/06 and a/0270/07;

NOTING Trial Chamber I's oral Order of 8 January 2010⁵ in which the Chamber requested that the documents be distributed immediately to the parties and participants after discussions between Me Keta, the Defense and the Registry;
