
**NOTING** the *Decision Setting a Time Limit for the Parties' Replies to 8 Victims' Applications for Participation* dated 24 August 2010;<sup>1</sup>

**NOTING** the *Decision Setting a Time Limit for the Parties' Replies to 87 Applications for Victims' Participation in the Proceedings and a Deadline for the Filing of Applications for Participation* dated 27 July 2010;<sup>2</sup>

**CONSIDERING** that the Single Judge ordered the Registry to transmit to the defence copies of the 8 applications which were transmitted to Pre-Trial Chamber I on 12 August 2010,<sup>3</sup> in which names, addresses and other sensitive information which could lead to the identification of the Applicants are redacted;

**CONSIDERING** that the Single Judge has previously required that redactions to applications in the present case should, as a matter of principle, be the same as those in the Abu Garda case;<sup>4</sup>
