
**Others**

1. On 16 March 2011, the Presidency of the International Criminal Court constituted Trial Chamber IV and referred to it the case of *The Prosecutor v. Abdallah Banda Abakaer Nourain and Saleh Mohammed Jerbo Jamus* ("Banda and Jerbo case").<sup>1</sup> The record of the proceedings was transmitted on the same day.
2. The Presidency decided that the Chamber shall be composed as follows:
  - Judge Fatoumata Dembele Diarra
  - Judge Joyce Aluoch
  - Judge Silvia Fernández de Gurmendi.
3. On 17 March 2011, the judges of Trial Chamber IV elected a Presiding Judge in the *Banda and Jerbo* case pursuant to Regulation 13(2) of the Regulations of the Court and **HEREBY DECLARE** that Judge Joyce Aluoch is Presiding Judge in the case.


