Decides, with reasons to follow and without prejudice to its final determination, to suspend the Impugned Decision.

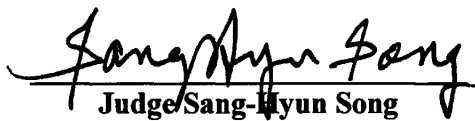
