NOTING the Order of Trial Chamber IV (“the Chamber”) requesting observations from the legal representatives on the agreement as to evidence pursuant to Rule 69 of the Rules of Procedure and Evidence dated 22 June 2011 and instructing representatives of participating victims to consult with their clients to determine whether they agree to the disclosure of their identities;¹

NOTING the Observations of Ms Héléne Cissé, the Legal Representative of Victims a/0457/09 and a/0458/09, on the agreement as to evidence pursuant to rule 69 of the Rules of Procedure and Evidence;²


NOTING the Notification of appointment of common legal representatives of victims dated 14 September 2011;³

NOTING article 68(1) and (3) of the Rome Statute and rule 89(1) of the Rules of Procedure and Evidence;

CONSIDERING that Victims a/0457/09 and a/0458/09 have expressed to their legal representatives their agreement to having their anonymity lifted towards the parties;⁴

CONSIDERING that the Chamber has instructed the Registry to file the relevant information regarding the identities of victims who have given their consent to lift their anonymity towards the parties;⁵

TRANSMITS to the parties, in the record of the case, the identities of the two victims who have agreed to lift their anonymity as well as their dates of birth.⁶
