



1. On 29 March 2012 the Presidency of the International Criminal Court constituted Trial Chamber V,<sup>1</sup> referred to it the case of *The Prosecutor v. Francis Kirimi Muthaura and Uhuru Muigai Kenyatta* and transmitted to it the full record of the proceedings before Pre-Trial Chamber II.<sup>2</sup>
2. On 26 April 2012 the judges of Trial Chamber V elected a Presiding Judge in the case against Mr Francis Kirimi Muthaura and Mr Uhuru Muigai Kenyatta pursuant to Regulation 13(2) of the Regulations of the Court and **HEREBY DECLARE** that Judge Kuniko Ozaki is Presiding Judge in the case.


