**NOTING** Resolution 1970<sup>1</sup>, adopted by the United Nations Security Council ("UNSC") on 26 February 2011, whereby the UNSC *inter alia* referred the situation in the Libyan Arab Jamahiriya ("Libya") since 15 February 2011 to the Prosecutor of the Court, in accordance with article 13(b) of the Rome Statute ,

**NOTING** the "Decision on the Prosecutions Application for a Warrant of Arrest against Muammar Mohammed Abu Minyar Gaddafi, Saif Al-Islam Gaddafi and Abdullah Al-Senussi" dated 27 June 2011;<sup>2</sup>

NOTING the Warrant of Arrest for Abdullah Al-Senussi dated 27 June 2011;3

NOTING the "Request to the Lybian Arab Jamahiriya for the arrest and surrender of Muammar Mohammed Abu Minyar Gaddafi, Saif Al-Islam Gaddafi and Abdullah Al-Senussi";<sup>4</sup> the "Request to States neighboring the Libyan Arab Jamahiriya for the arrest and surrender of Muammar Mohammed Abu Minyar Gaddafi, Saif Al-Islam Gaddafi and Abdullah Al-Senussi";<sup>5</sup> and the "Request to all States Parties to the Rome Statute for the arrest and surrender of Muammar Mohammed Abu Minyar Gaddafi, Saif Al-Islam Gaddafi and Abdullah Al-Senussi";<sup>6</sup> and the "Request to the United Nations Security Council members that are not States Parties to the Rome Statute for the arrest and surrender of Muammar Mohammed Abu Minyar Gaddafi, Saif Al-Islam Gaddafi and Abdullah Al-Senussi";<sup>6</sup> and the "Request to the Statute for the arrest and surrender of Muammar Mohammed Abu Minyar Gaddafi, Saif Al-Islam Gaddafi and Abdullah Al-Senussi";<sup>6</sup> dated 4 July 2011;<sup>7</sup>

**CONSIDERING** that Pre Trial Chamber I instructed the Registry to transmit, in consultation and coordination with the Prosecutor the request for cooperation seeking the arrest and surrender of Muammar Gaddafi, Saif Al-Islam Gaddafi and Abdullah Al-Senussi to all States Parties to the Statute, all of Libya's neighboring countries and to the United Nations Security Council members that are not States Parties to the Statute as well as to any other State which may be necessary;<sup>8</sup>

**NOTING** Articles 58, 59, 87 (2), 87(5) (a), 89(1) of the Rome Statute, Rules 117 and 176(2) of the Rules of Procedure and Evidence;

#### **INFORMS** the Chamber as follows:

- 1. On 17 March 2012, the Registry was informed that Abdullah Al-Senussi had been arrested in Mauritania.
- On the same day, after consultations took place with the Office of the Prosecutor, the Registry sent by fax a confidential request for arrest and surrender to the Minister of Foreign Affairs (in annex).
- 3. On 18 March 2012, the Mauritanian media reported that a request had been sent by the Court. On the following day, the Registry reclassified the request as public.
