PRE-TRIAL CHAMBER I ("the Chamber") of the International Criminal Court ("the

Court");

**NOTING** the Decision assigning the situation in the Democratic Republic of Congo

("the DRC") to Pre-Trial Chamber I issued by the Presidency on 5 July 2004;1

NOTING article 39(2)(b)(iii) of the Rome Statute ("the Statute") pursuant to which

the functions of the Pre-Trial Chamber shall be carried out either by three judges of

the Trial Division or by a single judge in accordance with the Statute and the Rules of

Procedure and Evidence;

NOTING article 57(2)(b) of the Statute pursuant to which a single judge of the Pre-

Trial Chamber may exercise the functions provided for in the Statute, unless

otherwise provided for in the Rules of Procedure and Evidence or by a majority of

the Pre-Trial Chamber:

**NOTING** rule 7(1) of the Rules of Procedure and Evidence and regulation 47(1) of

the Regulations of the Court pursuant to which the designation of a single judge shall

be based on criteria agreed upon by the Pre-Trial Chamber, including seniority of age

and criminal trial experience;

**CONSIDERING** that at this stage of the proceedings in *The Prosecutor v. Thomas* 

Lubanga Dyilo in the situation in the Democratic Republic of the Congo, the

designation of a single judge will enable the Chamber to function properly and

efficiently;

FOR THESE REASONS,

**DECIDES** to designate Judge Sylvia Steiner as single judge of Pre-Trial Chamber I in

The Prosecutor v. Thomas Lubanga Dyilo as from 10 May 2007 until otherwise decided

by the Chamber;
