THE REGISTRAR of the International Criminal Court (the "Court");

NOTING the "Décision relative à la mise en œuvre de la norme 55 du Règlement de la Cour et prononçant la disjonction des charges portées contre les accusés" issued by Trial Chamber II (the "Chamber") on 21 November 2012 (the "Decision")¹;

NOTING article 64-5 of the Rome Statute, rule 136 of the Rules of Procedure and Evidence and regulations 22 and 27 of the Regulations of the Registry;

CONSIDERING that the Chamber ordered the severance in respect of the charges against the accused Mathieu Ngudjolo²;

CONSIDERING that the Chamber also ordered the Registry "to take all necessary measures" to, *inter alia*, make the separation of cases possible³;

CONSIDERING that pursuant to regulation 22 of the Regulations of the Registry "(...) part of one situation or case record shall be transferred to another situation or case record, for the reasons relating to, inter alia, a joinder or separation of trials under rule136";

INFORMS that following the separation of trials the case record ICC-01/04-02/12 has been created for the case *The Prosecutor v. Mathieu Ngudjolo Chui*;

INFORMS that the same level of confidentiality and the same access level to these court records and material will be preserved in the case ICC-01/04-02/12;

TRANSFERS the material of the case record ICC-01/04-01/07, as described in annexes 1 to 3 below, to the new case record ICC-01/04-02/12:

- list of transcripts transferred (Annex 2);
- list of evidence registered in the case transferred (Annex 3);

SUBMITS respectfully the above annexes on a confidential basis, in accordance with regulation 23 *bis* 1 of the Regulations of Court, as they contain information of a confidential nature.
