The Appeals Chamber of the International Criminal Court,

In the appeal of Mr Thomas Lubanga Dyilo against the decision of Trial Chamber I entitled "Judgment pursuant to Article 74 of the Statute" of 14 March 2012 (ICC-01/04-01/06-2842), and

In the appeals of Mr Thomas Lubanga Dyilo and the Prosecutor against the decision of Trial Chamber I entitled "Decision on Sentence pursuant to Article 76 of the Statute" of 10 July 2012 (ICC-01/04-01/06-2901),

Having before it the "Request for guidance regarding applicants for participation in the appeal phase", filed by the Registrar on 7 February 2013 (ICC-01/04-01/06-2977), informing the Appeals Chamber that there are 29 applications for participation in the present proceedings that were not transmitted to the Trial Chamber before the end of the trial phase and 3 applications for participation that were previously rejected as incomplete by the Trial Chamber, which are now complete, that four of those applicants are not yet legally represented, whereas the other applicants are represented by Mr Joseph Keta Orwinyo, and requesting guidance as to whether those 32 applications and a report thereon should be transmitted to the Appeals Chamber,

Considering that it is expedient to examine *in limine* whether the Appeals Chamber should consider new applications for participation at this stage of the proceedings,

- (2) Mr Thomas Lubanga Dyilo, the Prosecutor, Mr Joseph Keta Orwinyo and the Office of Public Counsel for victims, may by 16h00 on 25 February 2013, each file submissions on whether the Appeals Chamber should consider new victim applications given the current stage of the proceedings.
