#### **Prosecution's Submission**

- On 15 April 2013, the Single Judge ordered the Prosecution to "make available the Article 58 applications of the Office of the Prosecutor for the issuance of the two arrest warrants against Mr Ntaganda" ("the Arrest Warrant Applications").<sup>1</sup> Any request for redactions was to be made by 25 April 2013.<sup>2</sup>
- 2. On 25 April 2013, the Prosecution filed a request for redactions to the Arrest Warrant Applications.<sup>3</sup> On 2 May 2013, it filed an update to this request<sup>4</sup>.
- 3. On 10 May 2013, the Prosecution filed the redacted Arrest Warrant Applications.<sup>5</sup>
- 4. On 21 June 2013, the Prosecution filed a request to redact "Information in Supplementary Submissions related to the First Arrest Warrant Application and to Vary Protective Measures for Three Witnesses".<sup>6</sup>
- 5. On 15 July 2013, the Single Judge granted the request.<sup>7</sup>
- 6. The Prosecution hereby files in the record of the case the confidential redacted versions of the supplementary submissions related to the First Arrest Warrant Application.
