**Trial Chamber V(B)** ('Chamber') of the International Criminal Court in the case of *The Prosecutor v. Uhuru Muigai Kenyatta*, in accordance with Rule 132(2) of the Rules of Procedure and Evidence, hereby confirms the scheduling of a status conference for 5 February 2014 starting at 10h00 to 12h00, and thereafter, as required, from 14h00 to 16h00.

1. In order to facilitate the preparation of the parties and the participants, the Chamber issues the following agenda:
  - A. An update from the Office of the Prosecutor ('Prosecution') on the additional investigative steps being taken in relation to its case against Mr Kenyatta;<sup>1</sup>
  - B. The requests of the Prosecution seeking an adjournment of the provisional trial date;<sup>2</sup>
  - C. The request of the defence team for Mr Kenyatta ('Defence') of 13 January 2014 seeking that the Chamber dismiss the request of the Prosecution for an adjournment, and terminate the proceedings under Article 64(2) of the Rome Statute;<sup>3</sup> and
  - D. Other matters.
2. The discussion of all agenda items will, in principle, take place in public session.
3. The presence of Mr Kenyatta is not required on this occasion.




