THE REGISTRY of the International Criminal Court (the "Court"):

**NOTING** Resolution 1593 (2005) of the United Nations Security Council, referring the situation in Darfur to the Court<sup>1</sup>;

**NOTING** the warrants of arrest against Omar Al-Bashir dated 4 March 2009 and 12 July 2010<sup>2</sup>;

**NOTING** the "Request to all States Parties to the Rome Statute for the Arrest and Surrender of Omar Ahmad Al Bashir" issued by the Pre-Trial Chamber II ("the Chamber") dated 6 March 2009<sup>3</sup>;

**NOTING** the "Supplementary Request to all States Parties to the Rome Statute for the Arrest and Surrender of Omar Ahmad Al Bashir" issued by the Chamber dated 21 July 2010<sup>4</sup>;

**NOTING** the "Prosecution's urgent notification of travel in the case of *The Prosecutor v Omar Al Bashir*" dated 17 February 2014;

**NOTING** the "Decision Regarding Omar Al-Bashir's Potential Travel to the Democratic Republic of the Congo" ("the Decision") issued by the Chamber dated 26 February 2014;

**NOTING** articles 87(l)(a) and (5), 89(1) and 91 of the Rome Statute and Rule 176(2) of the Rules of Procedure and Evidence;

CONSIDERING that the Chamber ordered the Registry *inter alia* "to transmit the Decision to the Democratic Republic of the Congo", and "to prepare a report to the Chamber concerning Omar Hassan Ahmad Al-Bashir's visit to the Democratic Republic of the Congo in due course"<sup>8</sup>;

#### **INFORMS** the Chamber as follows:

- 1. On 26 February 2014, the Registry sent a note verbale to the Parquet Général of the Democratic Republic of the Congo reminding the Congolese authorities of their obligation of arrest and surrender of Mr Al-Bashir (Annex 1).
- 2. On 27 February 2014, the Registry sent a note verbale to the Parquet Général of the Democratic Republic of the Congo transmitting the French translation of the Decision (Annex 2).
- 3. The Congolese authorities have informed the Registry that Mr Al-Bashir left Kinshasa in the morning of 27 February 2014 at 10.30 am.
- 4. Annexes 1 and 2 are classified confidential as they make reference to the names and contact details of staff members of the Court as well as of the public servants of the Democratic Republic of the Congo and are official correspondences between a State and the Court.
