The Presidency of the International Criminal Court ("Court"),

In the application of Mr Narcisse Arido ("Applicant") pursuant to regulation 85(3) of the Regulations of the Court for judicial review of the Registrar's decision on legal assistance paid by the Court filed on 2 May 2014, with a confidential *ex parte* classification; <sup>1</sup>

NOTING the Presidency's "Decision on the application for judicial review of the 'Decision of the Registrar on Legal Assistance Paid by the Court dated 17 April 2014 (CSS/2014/269)' notified on 2 may [sic] 2014, ICC-01/05-01/13" filed on 12 May 2014, with a confidential ex parte classification, made available only to the Registrar and the Applicant ("Decision");<sup>2</sup>

NOTING the Presidency's "Order on the reclassification of the 'Decision on the application for judicial review of the 'Decision of the Registrar on Legal Assistance paid by the Court dated 17 April 2014 (CSS/2014/269)' notified on 2 may [sic] 2014, ICC-01/05-01/13' of 12 May 2014 (ICC-RoC85-02/14-2-Conf-Exp)" filed on 30 May 2014 ("Order");<sup>3</sup>

NOTING that in the Order, the Presidency considered that "in the present case there seems to be no *prima facie* reason to justify maintaining the confidential status of the Decision as a whole, including information identifying the Applicant";<sup>4</sup>

NOTING that in the Order, the Presidency ordered the Applicant and the Registrar to indicate and provide reasons for what information, if any, in the Decision should remain confidential;<sup>5</sup>

NOTING the Registrar's "Observations pursuant to the 'Order on the reclassification of the 'Decision on the application for judicial review of the 'Decision of the Registrar on Legal Assistance paid by the Court dated 17 April 2014 (CSS/2014/269)' notified on 2 may [sic] 2014, ICC-0l/05-0l/13' of 12 May 2014 (ICC-RoC8S-02/14-2-ConfExp)" filed on 5 June 2014, 6 stating that "the Registrar has not identified any information that should remain confidential";<sup>7</sup>

NOTING the Applicant's "Observations on the Presidency's 'Order on the Reclassification of the Decision of the Registrar on Legal Assistance Paid by the Court Dated 17 April 2014 (CSS/2014/269)' (ICC-RoC85-02/14-5-Conf-Exp)" filed on 6 June 2014, stating that "Ithe Applicant] does not consider that any information in the Decision should remain confidential, and therefore does not have any objection to the whole decision becoming public";9

HEREBY ORDERS the Registrar to reclassify the Decision as public.
