**Trial Chamber I** ('Chamber') of the International Criminal Court ('Court'), in the case of *The Prosecutor v. Laurent Gbagbo* ('*Gbagbo* case'), issues the following 'Decision notifying the election of the Presiding Judge'.

- On 17 September 2014, the Presidency of the Court re-constituted Trial Chamber I, composed of Judge Cuno Tarfusser, Judge Olga Herrera Carbuccia and Judge Geoffrey Henderson, and referred to it the *Gbagbo* case.<sup>1</sup> The record of the proceedings was transmitted to the Chamber on the same day.<sup>2</sup>
- Pursuant to Regulation 13(2) of the Regulations of the Court, the judges of Trial Chamber I elected a Presiding Judge and HEREBY DECLARE that Judge Geoffrey Henderson is the Presiding Judge.
