Judge Geoffrey Henderson, acting as Single Judge on behalf of Trial Chamber I ('Single Judge') of the International Criminal Court, in the case of The Prosecutor v. Laurent Gbagbo, having regard to Article 64(3) of the Rome Statute ('Statute'), Rule 132(2) of the Rules of Procedure and Evidence ('Rules') and Regulation 54 of the Regulations of the Court, issues the following 'Scheduling order and agenda for the status conference on 4 December 2014'.

- 1. On 4 November 2014, Trial Chamber I held its first status conference.<sup>1</sup> On that occasion the Chamber encouraged the parties and participants to enter into active discussions on the protocols to be used at trial and, in order to reach a certain degree of uniformity at the trial level, to use the protocols used in the Kenya cases as a starting point.<sup>2</sup>
- 2. On 17 November 2014, the Chamber set the commencement date for the trial for 7 July 2015. It directed the Prosecution to provide full disclosure of all material to the Defence, pursuant to Article 67(2) of the Statute and Rules 76 and 77 of the Rules, no later than 6 February 2015. By the same date, the Prosecution was directed to provide to the Defence its list of witnesses and list of evidence to be relied on at trial, and to disclose the reports of any expert witnesses to be called by the Prosecution. The Chamber finally stated that further directions on trial-related preparation will be provided by the Single Judge in due course.<sup>3</sup>

- 3. In order to facilitate the preparation of the parties and of the Legal Representative of victims, the Single Judge issues the following agenda for the status conference:
  - a) Update on the status of disclosure, pursuant to Rules 76 and 77 of the Rules as well as to Article 67(2) of the Statute (including the possibility of requests for delayed disclosure);
  - b) Views of the parties and participants, and update on any on-going discussions, on the following protocols:
    - Protocols concerning the disclosure of the identity of witnesses of the other party and the handling of confidential information in the course of investigation;<sup>4</sup>
    - Unified protocol on the practices used to prepare and familiarise witnesses for giving testimony;<sup>5</sup>
    - (iii) Protocol on the vulnerability assessment and support procedure used to facilitate the testimony of vulnerable witnesses;<sup>6</sup> and
    - (iv) Proposed mechanism for exchange of information on individuals with dual status.<sup>7</sup>
  - c) Any other items.
- 4. Should the parties or the Legal Representative of victims wish to raise any particular issues under agenda item c), they are requested to inform the Single Judge, and if appropriate the other parties and participants, thereof by
