THE REGISTRY of the International Criminal Court (the “Court”):

NOTING the “Prosecution's Notification of Travel in the Case of *The Prosecutor v Omar Al Bashir*”¹ issued by Pre-Trial Chamber II dated 8 December 2014;

NOTING the “Decision on the ‘Prosecution's Notification of Travel in the Case of *The Prosecutor v Omar Al Bashir*’”² (the “Decision”) dated 8 December 2014;

NOTING articles 87(1)(5) (a) and 89(1) of the Rome Statute, rule 176(2) of the Rules of Procedure and Evidence and regulation 23*bis* of the Regulations of the Court;

CONSIDERING that the Chamber “a) invite[d] the competent authorities of the Federal Republic of Ethiopia to arrest Omar Hassan Ahmad Al-Bashir immediately and to surrender him to the Court; b) order[ed] the Registrar to send a Note Verbale to the Federal Republic of Ethiopia: (i) reminding the Ethiopian authorities of the request for the arrest and surrender of Omar Hassan Ahmad Al-Bashir transmitted to said authorities following the 10 October 2013 Decision enquiring about the visit of Omar Hassan Ahmad Al-Bashir; and (ii) reminding the Federal Republic of Ethiopia of SC Resolution 1593(2005) and inviting said State once more to cooperate with the Court in his arrest and surrender to the Court; c) order[ed] the Registrar to notify the present decision, to the competent authorities of the Federal Republic of Ethiopia”³;

CONSIDERING that the Chamber ordered “the Registrar to prepare a report to be filed with the Chamber in due course concerning said visit”⁴;



INFORMS the Chamber as follows:

1. On 8 December 2014, a note verbale as well as the Decision of the Chamber were delivered to the Permanent Representation of the Federal Democratic Republic of Ethiopia to the United Nations (United States of America) as well as sent by email to the Embassy of the Federal Democratic Republic of Ethiopia in Brussels (Belgium).
2. To the date of this filing, the Registry has not received any reply to its requests from the Ethiopian authorities.
3. From the media reports it follows that Omar Al Bashir attended the 20th anniversary of the adoption of the Constitution in the Federal Democratic Republic of Ethiopia on 8 December 2014.
4. The present report is filed public in line with the classification of the Decision. Annex 1 is submitted as confidential as it refers to the names of staff of the Court and of the Permanent Representation of the Federal Democratic Republic of Ethiopia in New York.
