NOTING the "Decision on responses to observations submitted under Rule 103"¹ ("the Decision of 21 November 2008") issued by Pre-Trial Chamber II ("the Chamber") on 21 November 2008;

NOTING the "Report of the Registrar on the execution of the "Decision on responses to observations submitted under Rule 103" dated 15 December 2008;²

NOTING articles 19(1) and 87 of the Rome Statute; rules 58(3), 103(1) and (2) and 176(2) of the Rules of Procedure and Evidence, and Regulation 24bis of the Regulations of the Court;

CONSIDERING that, in the Decision of 21 November 2008, the Chamber requested the Prosecutor, the Defence and the Republic of Uganda to respond, no later than 15 December 2008, to the observations by the Uganda Victims' Foundation and Redress;

CONSIDERING that, in its report of 15 December the Registrar informed the Chamber that she had not received any report from the Republic of Uganda but would inform the Chamber as soon as the report would be submitted;

CONSIDERING that on 16 December, the Registrar received an application for extension of time from the Republic of Uganda;³

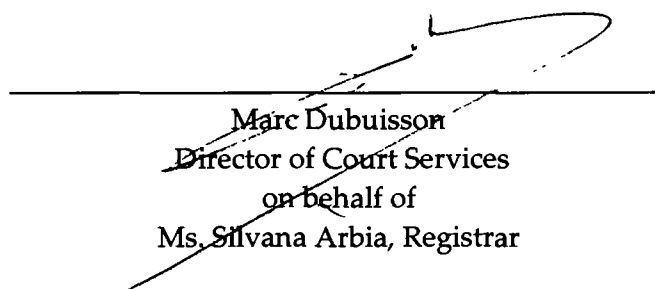
