**THE PRESIDENCY** of the International Criminal Court (the “Court”);

**NOTING** the fourteenth plenary of the judges held on 13 March 2009, during which, *inter alia*, Judges Akua Kuenyehia and Anita Ušacka were assigned to the Appeals Division, Judges Fumiko Saiga, Sanji Mmasenono Monageng and Cuno Tarfusser were assigned to the Pre-Trial Division;

**NOTING** the decision of the Presidency of 24 October 2008 constituting Pre-Trial Chambers whereby, *inter alia*, Pre-Trial Chamber II and Pre-Trial Chamber III were composed of Judges Hans-Peter Kaul, Mauro Politi and Ekaterina Trendafilova;<sup>1</sup>

**NOTING** that the term of office of Judge Mauro Politi ended on 10 March 2009;

**NOTING** article 39 of the Rome Statute of the International Criminal Court and regulation 46 of the Regulations of the Court;

**HEREBY DECIDES** that henceforth:

- (i) The situation in the Central African Republic shall be assigned to Pre-Trial Chamber II;
- (ii) Pre-Trial Chamber III shall be dissolved;
- (iii) The Pre-Trial Chambers shall be constituted as follows:


