THE PRESIDENCY of the International Criminal Court notes that on 17 March 2015, Judge Cuno Tarfusser filed a request before the Presidency pursuant to article 41(1) of the Rome Statute of the International Criminal Court ("Statute") and rule 33(1) of the Rules of Procedure and Evidence ("Rules"), wherein Judge Tarfusser requested to be excused from his function as a judge of Trial Chamber I in the case of *The Prosecutor v. Laurent Ghagbo and Charles Blé Goudé*.

On 17 March 2015, the Presidency granted Judge Tarfusser's request for excusal from Trial Chamber I (Annex I).

The Presidency recalls article 39(2)(b)(ii) of the Statute, rule 38 of the Rules and regulation 15(1) of the Regulations of the Court.

The Presidency hereby decides to recompose Trial Chamber I as follows effective 17 March 2015:
